4. Discussion and Action Relative to the Executive Session.

a. Land Acquisition Related to the Construction of a New Wastewater Treatment Plant. On a motion by Mr. Rowell, the Board directed Mr. Fry to tell Garver, USA to amend the TCEQ Application for the new Wastewater Treatment Plant to include the entirety of the acreage to be purchased as being necessary for District facilities including the new Wastewater Treatment Plant. 6. Discussion and Action to Set the Tax Rate for the 2024-'25 Fiscal Year.

A brief discussion was held about the Operations and Maintenance (O&M) Tax and the Debt Service (I&S) Tax. Mr. Ayala of Hilltop Securities recommended an O&M Rate of \$0.10/\$100.00 of valuation and an I&S Rate of \$0.25/\$100.00 of valuation, for a total tax rate of \$0.35/\$100.00 of valuation. Mr. Rowell made a motion to set the tax rate for the 2024-'25 Fiscal Year at \$0.35/\$100.00 of valuation as detailed by Mr. Ayala. The motion was seconded by Mr. Harse and approved by a unanimous vote of those present.
